NOTIFICATION

In exercise of the powers conferred by sub-section (1) of section 122 read with section 47-A of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972), the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Change of Land Use (From Agriculture to Non-agriculture Purposes in Non-planning Areas) Rules, 2017:-

AMENDMENTS

In the said Rules.—

(1) in rule 4, for clause (b), the following clause shall be substituted namely:-

"(b) In case of dry lands, the Director shall take a decision himself to issue prior concurrence, after satisfying with the documents uploaded by the applicant under sub-rule (2) of rule 3."

(2) in rule 7, sub-rule (2) shall be omitted.
